In my view, that's bigger than just conspiracy. Of course, we all now know from the information that's been declassified out of the Durham annex that the Obama White House wanted a reassessment of Russiagate on the fly when everyone in the intelligence apparatus was very clear that there was no Russia collusion. They wanted a reassessment. And you had John Brennan and those guys of that ilk go and submit, again, faulty information which they leaked to the press to launch the massive Russiagate investigation which was a lie.
