Kamala Harris needs to lead the cabinet to invoke the 25th Amendment:

"First and foremost, what is clear from the Hur report is that Donald Trump should not be on trial for classified documents because the Presidential Records Act actually protects former presidents with the documents they take with them when they leave the White House. It doesn't protect anybody else except for presidents...It also demonstrates the fact that this justice department under Joe Biden is picking who they're going to charge base on politics and not about the law. That's two, and number three, which is more clear than anything is that Kamala Harris needs to lead the cabinet to invoke the 25th Amendment. This is beyond politics. This is about the country now and it is clear Joe Biden does not have the mental capabilities to be the commander in chief. The question is: Will the cabinet be loyal to Joe Biden or will they be loyal to the United States of America? Because we cannot have a chief executive who can't even remember when he left the vice presidency. That's how damning this report is."

It is incumbent upon Joe Biden to present himself before the American people:

"I totally believe there is enough there to warrant the 25th Amendment being executed, especially when you put that with the press conference that the president did impromptu yesterday. It was a terrible press conference. Our rivals around the globe Larry, they see this as well. They know how terrible this is and look, at the end of the day, it is incumbent upon Joe Biden to present himself before the American people and demonstrate his faculties. This is not a political point. This is about serious business. We have men and women who are in bases around the globe, specifically in the Middle East. They are in harm's way and if the commander in chief doesn't even remember when he left the vice presidency, he can't remember the names of world leaders, how is he going to make the tactical decisions at a moment's notice that they need for their lives to be protected? That matters more than Republicans. It matters more than Democrats. That is critical to our nation. So he needs to present himself...What did Joe Biden know...or what did he forget about what Merrick Garland was doing with the prosecution of Donald Trump? Because it is clear now after reading this report, that they have chosen to weaponize the justice department against President Trump, while all the while, making sure they did everything possible to protect Joe Biden because your lack of mental capability does not protect you from prosecution under the Espionage Act."
