If Somalia comes before America, why are you here?

“I think it's wrong, but that's typical for Ilhan. She’s always wrong about this stuff. If that’s how she feels, then why are you in the United States Congress? You know, our job is to uphold the Constitution and to do everything to promote our citizens in our districts and this country. And look, I understand she has a lot of Somalis in her district, so I get it, she has a lot of people there. But your job as a representative is to, yes, reflect the wills and desires of your district but also to uphold the constitution and to promote our country and to protect our country. I mean if Somalia comes before America, why are you here?”

He’s letting the radicals in his party determine the security of this nation:

"Yea, he’s lying. He lies all the time. This man was a plagiarist in the U.S. Senate. He was a plagiarist in law school. Guess what? He’s a liar. He’s saying whatever he feels he needs to say to get elected. But, the truth is, Joe Biden is the one who reversed all of President Trump’s policies on the border because they said it was inhumane. Well, what’s more inhumane than having girls sold into sex slavery? Don’t really know. What’s happening out there, at the southern border, is a tragedy for the country. And now, it’s being seen in every city in the country. So, Joe Biden is lying to the American people. He can reverse course today. I'd go over to the White House and help him. I know he’s down in Florida right now raising money, I could help him. I would be like ‘Sir do this, do this, do this,’ and the border would be secured. But he won’t do that, because: 1) he’s a liar, 2) he’s a radical, and 3) he’s letting the radicals in his party determine the security of this nation.”

I definitely believe those are grounds for impeachment:

“The President does have a responsibility to execute federal law. That’s his job. He is not doing that. He has directed Alejandro Mayorkas to make these crazy divergences from federal law when it comes to securing our southern border. So, if were going to impeach Alejandro Mayorkas for this, I definitely believe those are grounds for impeachment for Joe Biden.”
